



## Candidate and Donor Crowdfunding Rules and Disclaimers Pg. 1

*\*\*Amendment of Rules: I Am All Things Beautiful reserves the right to amend and/or adjust the rules as deemed beneficial to the best interests of the company.*

1. **Active Membership Requirement:** To be eligible to apply as a recipient candidate, individuals must be active members of "I Am All Things Beautiful" This includes regularly participating in the community by liking and commenting on posts and financially contributing \$1 - \$5 weekly to others' needs.
2. **Eligibility Criteria:** Candidates must be adults (18 years or older) and residents of the United States. They must demonstrate a verifiable need or hardship that aligns with the funding categories outlined.
3. **Funding Application Requirement:** Candidates must complete a funding application detailing their specific needs and how the funds will be utilized.
4. **Application Submission:** All applications must be submitted through the official IAMATB online application form by the specified deadline.
5. **Government-Issued ID Requirement:** Each candidate must include a copy of their government-issued ID (such as a driver's license or state ID) with their application.
6. **Candidate Vetting and Verification:** We take the vetting of our candidates very seriously. Before any applicant can become a candidate, we require them to undergo a comprehensive review process, which includes various assessments to ensure that we are supporting individuals who genuinely need assistance and are also aware of the importance of being responsible and respectful of the resources provided to them by our community of donors. Therefore, all applicants are required to submit: a legal ID and provide character letters and/or letters of recommendation from reputable contacts, such as parents, community leaders, employers, pastors, or religious leaders. They must also provide answers to the following questions: How did you get into this situation? What have you done to resolve your issue? What is your plan to avoid this mishap in the future?
7. **Verification of Information:** Candidates must provide accurate and truthful information in their applications. Any discrepancies or false information may result in disqualification.
8. **Privacy Notice:** To protect the security and identity of our candidates, we will not share their full names, and any photos will be distorted or blurred.
9. **Application Review Process:** Applications will be reviewed and voted on by a committee based on the severity of the need, eligibility criteria, and community engagement. The review process may take up to 7-10 days.
10. **Campaign Duration:** Each crowdfunding campaign may last from a few weeks to several months, depending on the momentum and the speed at which we can secure funding for the candidates. We will do our best to reach the requested amount; however, there is no guarantee of the amount raised or granted.

11. **Payment Disbursement Method:** To ensure the smooth distribution of funds, recipients must provide the following information to their bank for the wire transfer: Bank name, Account holder name, Account number, Routing number, SWIFT/BIC code (for international transfers).
12. **Funds Distribution:** Candidates will receive their funds within 7 to 10 business days after the campaign has ended, provided all requirements have been met.
13. **Active Participation:** Candidates must actively participate in their own crowdfunding campaign by sharing their campaign on social media, engaging with supporters, and encouraging community interaction to maximize visibility and support.
14. **Respectful Engagement:** All candidates must engage respectfully within the IAMATB community. Disrespectful behavior (e.g., bullying, harassment, negative comments, or soliciting dates) may lead to disqualification.
15. **Communication Requirement:** Candidates must maintain a working means of communication (e.g., phone, email, social media). If a candidate is unreachable, they may lose their funding opportunity.
16. **Notarized Documentation:** All required documentation must be signed and notarized before and after the campaign, as detailed in the application process. A summary detailing how the funds will be utilized. Acknowledgment of Receipt of funds, and a written testimony describing how the funds were helpful.
17. **Visibility of Fundraising Amount:** To promote transparency and accountability, the total amount of funds being raised for each candidate will be visible and updated daily on their respective campaign page.
18. **Testimony Requirement:** Candidates must submit a testimony about their experience after receiving assistance, which will be shared on IAMATB's social media pages.
19. **Campaign Limitations:** Candidates can only receive funding once to allow for broader community opportunities.
20. **Administrative Fee:** 7% administrative fee will be deducted from the total funds raised for each campaign to cover operational costs. If you do not specify a particular candidate or campaign, your donation will be treated as a general contribution, which will help support administrative and operational expenses, as well as assist with random donations in our giving initiatives.
21. **Financial Responsibility Disclaimer:** Candidates must sign a disclaimer acknowledging that IAMATB is absolved from any financial responsibility that may arise from the gifting, including taxes or other financial obligations.
22. **Confidentiality:** All personal information shared during the application process will be kept confidential and used solely for the purposes of the crowdfunding initiative.

23. **Appeal Process:** If a candidate is not selected, they have the right to request feedback on their application. Additionally, they can appeal the decision within [7-10 days]. This process allows candidates to understand the reasons for their non-selection and to contest the decision if they believe it was unfair.

25. **Non-Affiliation Statement:** IAMATB has no business affiliations or partnerships with any members or funding recipients. However, members of the IAMATB family and friends are eligible to receive funding.
26. **Merchandise Disclaimer:** Merchandise available on the IAMATB website and social media platforms is for purchase only. No compensation gifts or free merchandise are guaranteed to members or donors.
27. **Campaign Adjustment for Unmet Goals:** Early campaigns may take longer to reach their funding goals. If a goal is not met, the admin team may adjust, including revising campaign strategies or extending the funding timeline.
28. **Dispute Resolution:** In the event of a dispute, IAMATB will collaborate with the admin team and committees to address complaints and resolve issues positively. IAMATB retains the right to make final decisions deemed best for both the community and the organization.
29. **Commitment to Donors:** As a donor, you can be confident that we have done our due diligence and made every effort to ensure that your contributions are not going to waste. We are dedicated to fostering a community built on trust and accountability.
